## Minor joining an Adult Course

IELS will act responsibly to ensure the welfare of all minor students during scheduled school hours. The Adult Programme at IELS does not include supervision outside of school hours. IELS cannot accept responsibility for students less than 18 years of age on Adult Programmes when not at school.

It is the school's policy that students under 18 years of age keep to a curfew. The curfew for 16 & 17-year old is 12am. Holiday travel outside of Malta is not permitted without a signed Parental Consent form, which must be received by the School in advance.

We reserve the right to expel students who do not follow the stipulated curfew times or for any unacceptable behavior or lack of attendance, either in the school, accommodation or in any other place. Misconduct will not be tolerated and no refund for the remainder of the course or accommodation will be provided. Repatriation is at the student's expense. IELS does not take responsibility or accept liability for direct negligence or willful misbehavior of students.

As a minor on adult course, the rules that must be followed are:

- The student must attend all allocated lessons.
- The student must carry the IELS Student ID cards at ALL times (if lost, a replacement is at an extra charge).
- The student must be dressed appropriately for their school lessons.
- The student must be at their designated accommodation no later than midnight (24.00).
- Holiday travel outside of Malta is not permitted without a signed Parental Consent form, which must be received by the School in advance.
- No stealing, bullying, or any other unacceptable behavior is tolerated.
- Smoking is strictly forbidden throughout all IELS schools and residences.
- Minors are **NOT ALLOWED** to consume **ALCOHOL** or **DRUGS**. The possession or consumption of alcohol or drugs will not be tolerated. Any substances found will be confiscated and action will be taken by IELS staff. This may result in immediate expulsion and possible Police intervention.
- The student must **NOT** carry knives, guns, or any other weapons.
- The student must **NOT** litter. All rubbish must be placed in bins.
- The student must respect your place of accommodation, be neat and tidy, and ensure that you keep noise to a minimum after 23.00 hours.
