General Rules:

- Students must attend all allocated lessons and activities.
- Students must carry their IELS Student ID cards at ALL times. If lost, a replacement is at an extra charge.
- Students must wear their IELS designated wristband at ALL times. If lost, a replacement is at an extra charge.
- Students must be dressed appropriately for their school lessons.
- Students must be returning to their Accommodation right after IELS evening activity.
- No stealing, bullying, or any other unacceptable behavior is tolerated.
- Smoking is strictly forbidden throughout all IELS schools and residences.
- Students are **NOT ALLOWED** to consume **ALCOHOL** or **DRUGS**. The possession or consumption of alcohol or drugs will not be tolerated. Any substances found will be confiscated and action will be taken by IELS staff. This may result in immediate expulsion and the possible police intervention.
- Students younger than 18 years old are **NOT ALLOWED** to smoke **CIGARRETES**. Students over 18 must **NOT** smoke during activities or school times.
- Students must **NOT** carry knives, guns, or any other weapons.
- Students must **NOT** litter. All rubbish must be placed in bins.
- Students must respect their place of accommodation, be neat and tidy, and ensure that they keep noise to a minimum after 23.00 hours.

Students must follow all additional IELS Rules & Regulations, as per their place of accommodation, and observe the local laws of Malta. IELS reserves the right to provide warnings to students, restrict them from attending activities, and in serious cases expel students, for any unacceptable behavior or lack of attendance. Misconduct will not be tolerated and no refund for the remainder of the course booked or accommodation will be provided. Repatriation will be at the student's own expense.
